Adopted on 19 October 2022, the Digital Services Act (DSA) will fully apply from 17 February 2024. The regulation, with some amendments to the so-called safe harbours provisions of the 2000 e-Commerce directive, creates an extensive catalog of due diligence obligations for the online platforms, in particular for the social media platforms and search engines. The DSA also requires Member States to adopt several implementing measures for the new supervision mechanism involving Digital Services Coordinators. The European Commission devotes quite a lot of resources to cope with the huge tasks of overseeing the very large players.

The new obligations imposed on digital platforms as well as their enforcement raise a lot of new issues. This conference is an opportunity for us to discuss those issues.
